#### Why are Cold Flow Improvers needed for MGO?

As global shipping continues its shift toward cleaner low-sulfur fuels, Marine Gas Oil (MGO) has become a preferred choice in Emission Control Areas (ECAs). While MGO offers a simpler, more stable profile compared to hybrid VLSFOs, it remains vulnerable to several operational risks - one of the most critical being wax crystallization in low temperature environments.







In colder climates, paraffinic components in MGO can begin to crystallize into large wax structures. This can occur even before reaching freezing temperatures, as some fuels may begin to solidify well above 0°C. These crystals can obstruct filters, fuel lines and injectors, creating severe operational and safety risks. In extreme cases, fuel may become unpumpable, resulting in potential propulsion loss.

Cold Filter Plugging Point (CFPP) and Pour Point become essential indicators of fuel performance. Yet, while Pour Point is a standard ISO 8217 test, CFPP testing remains optional.

Octamar™ Winterflow has undergone independent and rigorous testing by Lloyd's Register across a wide range of MGO fuel samples, consistently demonstrating significant improvements in both Pour Point and Cold Filter Plugging Point (CFPP). These clear and repeatable results underline the product's robust performance across varied fuel qualities and cold flow conditions. As a result, Lloyd's Register has awarded it their official Performance Certification Seal .
